

THE TEA HOUSE TIMES TOUR AGREEMENT

The Tea House Times Tour to Charleston, Summerville, Wadmalaw Island will include day tours, transport, guides, gratuities, and some food-Monday, October 22 to Friday, October 26 (4 nights). The tour must reach a minimum of 20 persons to proceed. Hotel reservations must be made for all 4 nights to ensure our group rate. Participation and payment is expected for the tours and events as a package price and cannot be broken up. Prices are per person regardless of age. If the 20 person minimum is not met, you may choose to pay a higher rate for the tour portion in order to continue on or choose cancellation. Deposit checks and/or credit cards will not be cashed/charged until the 20 person minimum is met. Once the 20 person minimum is met, deposits are non-refundable.

You are expected to make your own hotel reservation and arrange for your own air and/or ground transportation to the hotel.

It is understood that The Tea House Times has organized tours for your convenience and serves to collect monies on behalf of the group for payment to the Charleston Convention and Group Services Inc. the company responsible for the tour arrangements and transportation. The CCGS is fully insured.

A non refundable deposit is due with this signed form ASAP. Total tour/event payment is \$550 per person.**
